Terms & Conditions:

- 1) I authorize Living Water Resorts to obtain my personal information to be used for club-related contact with me, and further agree to inform Living Water Resorts of any change of mailing address or email address.
- 2) Upon acceptance as a member, I agree to all terms and conditions of the club as stated in the club By-Laws.
- 3) All monies paid to Living Water Resorts, including but not limited to, deposits made on initiation fees and dues, are non-refundable.
- 4) I agree to receive regular email updates about the resort facilities.
- 5) Cranberry members are allowed to book starting times up to 14 days in advance. Please organize your group, as the Golf Shop will ask for all individual names **in your group** when booking your tee time.
- 6) House account cannot be used for any add-on purchases except for driving range membership. Pro shop gift certificates cannot be applied to house accounts.
- 7) **“No-Show” Policy:** Failure to arrive for a tee time without 24 hours’ notice will result in a “No Show Fee”. The fee for No Shows will be a \$39 flat rate on weekends or weekdays. \$29 Fee after 3pm. \$20 for 9 holes. When canceling, guests must speak with an agent directly.
- 8) **Cancellation Policy:** We will continue to accept a 24-hour cancellation policy for tee times with no penalty. Cancellations must be confirmed through the Golf Shop.
- 9) **Golf Association of Ontario:** Cranberry Golf Course is a member of the GAO. GAO Fees will be mandatory at \$40 HST per member for specific leagues and non-refundable
- 10) **House Account Commitments** are non-refundable. Your House Account Commitment fee will be added as a credit to your account for use at Station on the Green Bar & Grill, in the Pro Shop, Driving Range Membership & Individual Usage, as well as at the on-course Beverage Carts for use throughout the golf season. Golf Spending Commitment balances may not be carried over beyond the golf season and are not applicable for use at any other Living Water Resorts Restaurant or facilities. Please note: Golf Spending Commitment is NOT subject to HST.
- 11) **Dress Code is in effect.** Our Dress code is casual golf attire, slacks, dress pants, shorts, collared shirt for Men is required. Ladies may wear sleeveless shirts with collar or no collar with sleeves. Denim, Sweatpants, cut off shorts are prohibited. Proper footwear is required. No Sports cleats or metal spikes.
- 12) All league play concludes on September 30, 2025.
- 13) CHEQUES MUST BE MADE PAYABLE TO LIVING WATER RESORTS
- 14) Medical refund requests must be accompanied by a doctor’s note and provided to the general manager. Refunds will be prorated based on the date received and subject to management approval.
